## **JOB DESCRIPTION**

As a Medical Science Liaison (MSL), you'll be working in an international environment in which you can develop your talent and realize ideas and innovations within a small, passionate and high-performing team. - Provide product and scientific training to the affiliate cross-functional team.
- Participate in relevant congresses, symposia and other meetings.
- Oversee, interpret and adapt to new scientific data, competitive trends and product opportunities while ensuring a high scientific level of expertise within the therapeutic area of nephrology.
- Support sponsored clinical research activities, including phase 3 or 4 studies, as well as investigator sponsored studies and post-authorization safety studies.
- Facilitate and manage compassionate use and/or medical need programs, if appropriate.
- Implement and manage local patient support programs, if appropriate.
- Make sure that the values and culture are applied at all times while complying with all legal, regulatory, ethical and socially responsible standards.
